

# ETF Explorer Cashback Campaign Terms & Conditions

---

## 1. Campaign Period

The campaign runs from Wednesday, 3 June 2026 to Tuesday, 30 June 2026 ("Campaign Period").

---

## 2. Eligibility

Open to existing StashAway customers in Malaysia who:

- have never invested in ETF Explorer before
- 

## 3. Promotion Details

3.1. Eligible customers who apply the voucher code **ETFXJUN26** and make qualifying ETF Explorer buy orders during the Campaign Period will earn cashback as set out in the Cashback Tiers below.

3.2. Cashback is earned per qualifying buy order. The cashback amount per order is determined by the deposit amount for that order, as set out in Section 4.

3.3. Total cashback earned across all qualifying orders is capped at **MYR 250** per customer per campaign.

3.4. Cashback is credited as a single lump-sum payment into the customer's StashAway Simple portfolio at the end of the Campaign Period. Cashback is not paid per transaction.

3.5. The standard ETF Explorer buy order fee of USD 1.99 applies to all buy orders and is not waived under this campaign.

3.6. Sell orders and any other applicable fees (e.g. currency conversion) are not covered by this promotion.

#### 4. Cashback Tiers

Cashback per qualifying order is determined as follows:

Tier	Min. Deposit per Order (RM) - inclusive	Cashback per Order (RM)	Max Cashback (RM)
1	1,000	5	250
2	3,000	15	
3	5,000	25	

4.1. Tiers are assessed per individual buy order based on the deposit amount for that order.

4.2. A customer may mix tiers across different orders within the same campaign. For example, a customer may invest MYR 1,000 in one order (Tier 1, earn MYR 5) and MYR 5,000 in another order (Tier 3, earn MYR 25). Total cashback is the sum of cashback earned across all qualifying orders.

4.3. Buy orders below MYR 1,000 do not qualify for cashback under this campaign.

4.4. Once total cashback earned reaches MYR 250, no further cashback will be accrued for subsequent orders within the Campaign Period.

#### 5. Qualifying Orders

A buy order qualifies for cashback if all of the following conditions are met:

5.1. The voucher code **ETFXJUN26** has been successfully applied to the customer's account prior to the order being placed.

5.2. The buy order is placed and executed within the Campaign Period.

5.3. The deposit amount for the order meets the minimum threshold of MYR 1,000 (Tier 1).

5.4. The funds are eligible deposits as defined in Section 6.

5.5. The order is settled within the Campaign Period.

5.6. The total cashback accrued by the customer has not yet reached the MYR 250 cap.

## 6. Eligible Deposits

Only the following deposits are eligible to qualify as buy orders under this campaign:

- Fresh funds deposited from outside StashAway; and
- Internal transfers from StashAway Simple into ETF Explorer.

6.1. Transfers from other StashAway portfolios (excluding Simple) into ETF Explorer are not eligible.

6.2. Deposits received outside the Campaign Period will not qualify.

## 7. Cashback Payout

7.1. Total cashback earned across all qualifying orders will be calculated at the end of the Campaign Period and credited as a single payment into the customer's StashAway Simple portfolio by end of July 2026.

7.2. Cashback will not be paid out on a per-transaction basis during the Campaign Period.

7.3. If the customer does not hold an active Simple portfolio at the time of payout, StashAway will create a Simple portfolio on the customer's behalf and credit the cashback into that portfolio.

7.4. Cashback is non-transferable, non-exchangeable, and cannot be converted to cash outside of the Simple portfolio credit.

## 8. How to Participate

8.1. Log in to the StashAway app.

8.2. Go to More → Promotions → Enter promotion code, and enter **ETFXJUN26**.

8.3. Invest a minimum of MYR 1,000 into any ETF Explorer portfolio during the Campaign Period using eligible funds as defined in Section 6.

8.4. Cashback will be automatically calculated and credited to your Simple portfolio at the end of the campaign.
