

ETF Explorer August 2026 Cashback Campaign Terms & Conditions

1. Campaign Period

The campaign runs from 3 August 2026 to 31 August 2026 ("Campaign Period").

2. Eligibility

Open to all new and existing StashAway clients in Malaysia.

3. Promotion Details

3.1. During the Campaign Period, clients who deposit a minimum of RM 1,000 per buy order into any ETF Explorer portfolio will earn a cashback reward based on the following tiered structure:

Tier	Minimum Deposit per Buy Order (RM)	Cashback per Buy Order (RM)
1	1,000	10
2	3,000	20
3	5,000	30
4	10,000	50

Example: A client places a buy order of RM 3,500 on 10 August → qualifies for Tier 2 → earns RM 20 cashback. The same client places a second buy order of RM 1,200 on 20 August → qualifies for Tier 1 → earns an additional RM 10 cashback.

3.2. Cashback is awarded on a per buy order basis. There is no limit to the number of qualifying buy orders per client during the Campaign Period, subject to the total cashback cap in Section 3.5.

3.3. Only the following deposits qualify for cashback. Transfers from other StashAway portfolios (excluding Simple) into ETF Explorer are not eligible.

- Fresh funds deposited from outside StashAway; and
- Internal transfers from a StashAway Simple portfolio into ETF Explorer

3.4. Each buy order is assessed independently against the tier thresholds above. Only the highest applicable tier is awarded per buy order.

3.5. Total cashback earned per client is capped at RM 1,000 for the duration of the Campaign Period, regardless of the number of qualifying buy orders placed.

3.6. The voucher code as described in Section 4.2 must be applied prior to investing into any ETF Explorer portfolio. Buy orders placed before the voucher is successfully applied will not qualify.

3.7. Deposits received outside the Campaign Period will not qualify for cashback.

3.8. ETF Explorer fees (e.g. buy order fees, currency conversion) apply as usual and are not covered by this promotion.

4. How to Participate

4.1. Log in to the StashAway app (or sign up if you are a new customer).

4.2. Apply the voucher code:

- **New customers:** The voucher will be automatically applied to your account. No action required.
- **Existing customers:** Go to More → Promotions → Enter promotion code, and enter **ETFXAUG26**.

4.3. Deposit into any ETF Explorer portfolio using eligible funds as defined in Section 3.3 during the Campaign Period to earn cashback as per Section 3.

5. Cashback Fulfilment

5.1. Total cashback earned across all qualifying orders will be calculated at the end of the Campaign Period and credited as a single payment into the customer's StashAway Simple portfolio.

5.2. If the customer does not hold an active Simple portfolio at the time of payout, StashAway will create a Simple portfolio on the customer's behalf and credit the cashback into that portfolio.

5.3. Cashback will be credited by 30 September 2026.

5.4. Cashback amounts are non-transferable and cannot be exchanged for cash or other rewards.

6. General

6.1. StashAway reserves the right to modify, extend, or cancel the campaign at any time without prior notice.

6.2. In case of dispute, StashAway's decision is final.

6.3. StashAway may withhold or cancel the cashback if fraudulent or abusive behaviour is suspected, or if eligibility conditions are not met.
