

# StashAway Gold ETF Referral Campaign

## Terms & Conditions

### 1. Campaign period

The campaign runs from 4 February 2026 to 6 March 2026 (both dates inclusive).

### 2. Definitions

- **Referrer** — an existing client who refers a friend to invest with StashAway.
- **Referee** — a referred friend who invests with StashAway.
- **Investment portfolios** — General Investing by StashAway, General Investing by BlackRock®, Shariah Global Portfolio, Responsible Investing, Flexible Portfolios, and Thematic Portfolios.

### 3. Eligibility

- The campaign is open to all existing StashAway clients with a funded and active account.
- Referees must be new to StashAway and have not previously signed up for an account.
- Referees must sign up using the referrer's unique referral link and make qualifying deposits during the campaign period.
- Only sign-ups made via the referral link qualify for rewards.

### 4. Referral rewards for referrers

For each successful referral during the campaign period, referrers will receive:
